

## NOTICE OF PUBLIC HEARING

### PROPOSED DECLARATION OF A STAGE 2 WATER SUPPLY EMERGENCY

#### **Industry Public Utilities Commission Resolution No. IPUC 2022-11 Declaring a Stage 2 Water Supply Emergency, Making Findings in Support Thereof, and Adopting a Notice of Exemption Regarding Same**

On October 19, 2021, Governor Gavin Newsom issued a Proclamation of a State of Emergency that proclaimed that eight southern California counties, including Los Angeles County, are experiencing severe drought conditions. On January 4, 2022, the SWRCB adopted a resolution establishing emergency regulations prohibiting certain wasteful water use practices statewide and encouraging Californians to monitor their water use more closely, while supporting habits to use water wisely. On March 28, 2022, through Executive Order N-7-22, Governor Gavin Newsom called upon each urban water supplier to adopt shortage levels between 20 and 30 percent based on local conditions. A resolution declaring water use efficiency practices and water conservation measures for users, which established penalties for violating any water use restrictions and/or water conservation measures required during a Stage 2 Water Shortage Emergency is proposed to be adopted by the **Industry Public Utilities Commission at its regular meeting on June 9, 2022, at 8:30 AM**, or as soon thereafter as the matter may be heard. Members of the public will be able to attend the meeting telephonically and offer public comment during the public hearing by calling the conference call number and entering a Conference ID, which will be listed on the June 9, 2022 Industry Public Utilities Commission agenda, posted on the "Agenda" section of the City of Industry's website no less than 72 hours prior to the public meeting. A general summary of the Stage 2 water use restrictions and water conservation actions included in the proposed resolution is set forth below:

- Stage 2 Water Supply Emergency – Outdoor watering limited to two (2) times a week between 5 P.M. and 9 A.M. on Monday and Friday.
- Repair leaks within 3 days of receiving notice from the Industry Public Utilities Waterworks System

These conservation restrictions will be administered initially on an educational basis and escalate to fines for repeated violations. The restrictions, if approved by the Industry Public Utilities Commission, shall take effect June 9, 2022, and shall remain in effect until otherwise repealed or amended by the Industry Public Utilities Commission.

Any person wishing to be heard regarding this matter may appear in person or telephonically at the above time and date. Written comments may be sent via US Mail or by hand delivery to the Industry Public Utilities Commission at the address listed above or via email to the email address listed above. All comments must be received at, or prior to, the date and time of the hearing listed above.

If you challenge the water conservation rules in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Commission at, or prior to, the public hearing.
